Information on the consideration of sustainability goals (SDGs) in project funding can be found in the Infoportal.
11. cost and financing plan
Please complete the annex Sample Financing Plan Department of Culture: Cultural Funding.

 - ➔ name it as follows: PROJECT TITLE_APLICANT`S NAME_VIDEOLINK.pdf
- Letter of intent from a venue: letter from the planned venue stating that the project is desired and supported there
 - ➔ upload document as pdf
 - ➔ name document as follows: PROJECT TITEL_APPLICANT`S NAME_VENUE.pdf
 - ➔ Several venue certificates can be submitted
- for projects in public spaces: approval that the project can be approved at the desired location (online application procedure at the Event Management of the City of Hannover: <https://e-government.hannover-stadt.de/evenkoo/>)
